



# Control-C Cookie Policy

## 1. About This Policy

This Cookie Policy explains how Control-C uses cookies, pixels, and similar technologies (collectively, "cookies") when you visit our websites, access the Control-C platform, or interact with our communications. It complements our Privacy Policy ([./privacy-policy](#)).

## 2. What Are Cookies?

Cookies are small text files stored on your device when a website loads in your browser. They help the site remember your actions and preferences (such as login state or language) and support analytics and performance metrics. We also use local storage and similar technologies that operate in a comparable manner.

## 3. Cookies We Use

We categorize cookies as follows:

- **\*\*Strictly necessary\*\***: Required for core functionality such as authentication, security, and load balancing. These cannot be disabled without impacting the Service.
- **\*\*Performance and analytics\*\***: Help us understand how visitors interact with our site and product so we can improve navigation, content, and features.
- **\*\*Functional\*\***: Remember preferences such as language, region, or saved filters.
- **\*\*Marketing\*\***: Enable us to deliver relevant communications and measure campaign effectiveness. Marketing cookies are used only where you have provided consent.
